
Sponsorship FAQ

This high-caliber conference is solely dedicated to infant mental health best practices, attracting world renowned clinicians, policy makers, and research faculty who present cutting edge information about attachment, early relationship development, and reflective supervision for work with infants, young children and their families. The conference challenges our hearts and minds, deepens understanding of our work, and reenergizes our dedication to promoting and supporting secure, nurturing relationships early in life – when they matter most.

For the 2019 Conference, in addition to our goal of providing stellar professional development, MI-AIMH is also raising additional funds to help us continue offering conference scholarships and offset conference costs as well as support MI-AIMH's work and growth.

Is a sponsorship tax-deductible?

Mostly. A sponsorship qualifies as tax-deductible only to the extent that it exceeds the value of any benefits the sponsor receives in return (e.g. tickets, conference registration, etc.). For example, a Strong Relationships Sponsor (\$2,500) receives 1 complimentary conference registration with their sponsorship. The tax-deductible amount of the sponsorship is then \$2,120 (\$2,500 – 1 registration @ \$380). The exception is if the sponsor declines to use the registration or offers the conference registrations back to MI-AIMH to use as scholarships, then the full amount would be tax-deductible. MI-AIMH will receipt all sponsorships accordingly. Please note: This information is not to take the place of professional legal or accounting advice. Dr. Kristie Brandt is an internationally known teacher, trainer, clinician, and consultant, and directs the Parent-Infant & Child Institute in Napa, CA that provides clinical services for children age 0-5, consultation for parents and providers, and professional training. She founded the Napa Infant-Parent Mental Health Fellowship in 2002 and continues to direct this renowned program of the University of California Davis Extension. She is a Child Trauma Academy Fellow and NMT Metric Mentor with Dr. Bruce Perry. For over a decade, she has been a national trainer with the Brazelton Touchpoints Center at Boston Children's Hospital. Dr. Brandt is lead editor of the book "Infant & Early Childhood Mental Health: Core Concepts & Clinical Practice" (American Psychiatric Publishing) and author of the book "Facilitating the Reflective Process: An Introductory Workbook." She earned her Master's and Doctorate degress at Case Western Reserve University, and completed a post-doctoral Fellowship in Infant-Parent Mental Health. Dr. Brandt is an endorsed Infant Mental Health Specialist & Clinical Mentor through MI-AIMH. She developed the Mobius Care therapeutic model and trains worldwide on this approach, and she provides reflective supervision across the U.S. and abroad. She was the Chief Public Health Manager in California's Napa Valley, and retired after 25 years of public service. While overseeing public health, she researched home visiting models, and developed the award winning Therapeutic Child Care Center, the first full-day, full-year program of its kind in the U.S.

Dr. Cassandra Joubert received a Doctor of Science degree in maternal and child health from the Johns Hopkins School of Hygiene and Public Health (now the Bloomberg School), and a graduate certificate in infant-parent mental health from the University of Massachusetts at Boston/Napa satellite. She is currently the Director of the Central California Children's Institute (CCCI) and tenured Professor in the Department of Public Health at California State University, Fresno. In her role as CCCI Director, she provides leadership for community-oriented, applied research, practice and training programs devoted to improving the well-being of children in the Central Valley of California. In addition, the Institute currently is engaged in programs addressing racial and ethnic disparities in child health, and in African American infant mortality reduction. Dr. Joubert is the author of an award-winning book "Losing Control: Loving a Black Child with Bipolar Disorder" published in 2007. Her child advocacy work focuses on how early relationships between caregivers and young children shape the brain for early learning, prevention of mental illness, and life success. She is President-Elect of the National School-Based Health Alliance and serves on the boards of the California Health Collaborative, Black Women Organized for Political Action, and Exceptional Parents Unlimited (Emeritus).

Dr. Deborah Weatherston is the founding Executive Director of the Alliance for the Advancement of Infant Mental Health, INC[®], a nationally and internationally recognized organization whose mission is to promote workforce development through the competency-based MI-AIMH Endorsement for Culturally-Sensitive, Relationship-Focused Practice Promoting Infant Mental Health. She earned her graduate degrees from Wayne State University where she co-developed and directed the Graduate Certificate in Infant Mental Health at Wayne State University in Detroit, Michigan from 1988-2002. She became the Executive Director of the Michigan Association for Infant Mental Health in 2002 and continued in the role until 2016. She has written extensively about infant mental health principles and practice and, most recently, about reflective supervision as a cornerstone for effective work with infants, very young children and families. Of additional interest, she was a Zero to Three Fellow (1999-2000), a consulting editor for the Infant Mental Health Journal, and is a Board Member of the World Association for Infant Mental Health where she is currently the Editor of WAIMH Perspectives in Infant Mental Health.
